## OPEN FORUMS FOR PEOPLE WITH DISABILITIES

Rhode Island Statewide Independent Living Council and National Federation of the Blind of RI will be co-hosting an open forum for all people with Disabilities and their families on Friday, July 31<sup>st</sup>, 2015, from 2:45 – 4:45 PM, at East Providence Public Library's Program Room, 41 Grove Ave, East Providence, RI

The **Rhode Island Statewide Independent Living Council (RISILC)** is a non-profit organization dedicated to promoting Independent Living for people with disabilities throughout the state. The Council's membership is comprised of volunteers appointed by the Governor of Rhode Island, and the majority of its members are people with disabilities.

The **National Federation of the Blind (NFB) of RI** is a membership based consumer advocacy organization. The NFB offers such services as access to newspapers and magazines through Newsline, scholarship to college blind students, Braille education programs for blind children and mentoring. The NFB improves blind people's lives through advocacy, education about the capacity of blind individuals, research, technology and programs that promote a positive view of blindness, independence and self-confidence.

These forums are an opportunity for ALL people with disabilities and their families to speak out and voice their concerns. There will be a panel of representatives present from several state agencies and community-based organizations to listen to the participants. These forums are being held throughout the state during the week of July  $27^{th} - 31^{st}$ , as part of the  $25^{th}$  year anniversary celebration of the signing of the Americans with Disabilities Act.
