4. Summary of Follow-ups from Meeting

- The SRC team will get together and work on CRP Survey results. (CRP Committee)
- Formulate notice of membership recruitment for the SRC. (Nancy)

5. ORS Director's Report - Ronald Racine

• There are no more people on the Category I Waitlist. ORS is working with clients in Category II of the Waitlist to get them off in the next three to four months. This is a big difference from where ORS was just two year ago when the Waitlist had all categories closed.

Clients are served in the following order as funding allows:

- Priority Group 1- Individuals with the most significant disabilities
- Priority Group 2- Individuals with significant disabilities
- Priority Group 3- All other eligible individuals

Individuals within each group are served in order of application date.

• Reallotment Funds – ORS has received five million in reallotment funds partially due to other states not being able to match state to federal funding. Out of this five million, ORS is required to spend at least 15% on Pre-Employment Transition Services (Pre-ETS). The State has pushed off the budget process, waiting to see if they can utilize COVID-19 relief money to help alleviate the deficit. ORS is guaranteed funding for this fiscal year but will have to be careful not to exceed our state matching funds once the new budget is finalized.

6. Chair's Report – Dr. Judith Drew

- Update on the Community Rehabilitation Providers section of the Comprehensive Needs Assessment for 2020. The SRC sub-committee has been working since August on the survey. The response rate was roughly 35%. We are working on analyzing the data and our report should be ready in December. Judi thanked everyone who has been working on this project; Catherine, Malissa, Christine, Barbara, Nina and Nancy.
- Remind that this is still the 100 Anniversary year of the Rehabilitation Program. There is information and updated anniversary content at, VR100 /Vocational Rehabilitation 100th Anniversary.
- Governor's Coaching Coalition their enthuses is on helping anyone in RI who needs a job to get carrier coaching. It is a professional development program for career coaches in RI.
- ➤ Council voted unanimously to nominate Cathy Andreozzi to the Council.

7. Let's Get Back to Work and COVID-19 - Joe Murphy

In 2018 the Let's Get Back to Work Initiative began. It was formed to eliminate the Silo Effect in the rehabilitation and employment communities in RI by having all state agencies and provider networks linked together. Since COVID-19, there is a new initiative called Back to Work RI, which is very similar to the Let's Get to Work Imitative.

Back to Work RI will focus on those receiving unemployment benefits and the state's more vulnerable communities, with the objective of assisting those in need and ensuring that the economic comeback leaves no one behind.

- Participants will work with a career coach who provides job counseling and connects them with resources.
- The coaches will receive training from the nonprofit Markle Foundation's Skillful Initiative and Operation HOPE, an Atlanta-based organization.
- Back to Work RI intends to offer several pathways for people to quickly get back to work while gaining the skills needed to establish sustainable, successful careers in areas such as health care, financial services and IT.

ORS wants to ensure that this newly named program works with people with disabilities, and has an avenue to work with students in high school and then move onto adult services.

- ORS worked with the Workforce Innovation Technical Assistance Center (WINTAC), to help provide technical assistance on a wide variety of subjects including customized employment, supportive employment and an integrated resource team model, which is in use at the Department of Labor and Training (DLT) in the Disability Employment Initiative (DEI). The DEI is a person-centered plan that aims to improve education, training and employment opportunities and outcomes for youth and adults with disabilities who are unemployed, underemployed and/or receiving Social Security disability benefits. Person-centered plans examine the obstacles to work while the Governor's newer program enthuses help for those who have lost work or businesses due to COVID-19.
- This Governor Coaching Coalition will be facilitated by an out-of-state group that will be training the 30 35 Navigators (career coaches) using The Coronavirus Aid, Relief, and Economic Security (CARES) Act money. ORS involvement is important to help make sure the navigators have a focus on people with disabilities.

COVID-19 - ORS is still working lobby free and not allowing a lot of community-based services. We are working with providers to make sure they have COVID-19 plans in place.

8. Preliminary Review of CRP Survey- John Valentine

- Noted difference from the last CRP survey; there were far more open-ended questions.
- The response rate was about 38%, which is a strong number, one higher than most states I have looked at.
- Optimistic we will have good data as we break it down.

9. Review of Meeting Schedule and Recording of Meetings - Nancy Baker

Members were asked if they had any difficulty/conflicts with this year's schedule, and no one did. The schedule was solidified and has been posted to the Secretary of State's Website.
